Financial Interests	This is where an individual may get direct financial benefits from the consequences of a decision they are involved in making for examples:-

Indirect Interests	This is where an individual has a close association with an individual who has a financial interest, a non-financial professional interest or a non-financial personal interest in a decision they are involved in making, for example,
	<ul> <li>Spouse / partner;</li> <li>Close family member or relative e.g., parent, grandparent, child, grandchild or sibling;</li> <li>Close friend or associate; or business partner.</li> </ul>
Loyalty	Organisational (loyalty) interests
Interests	<ul> <li>Carefully consider whether an individual's role in another organisation could result in actual or perceived conflicts of interest – could it influence the decisions they make, such as decisions on the spending of taxpayers'</li> </ul>

The NHS guidance defines a 'conflict of interest' as:

"A set of circumstances by which a reasonable person would consider that an individual's ability to apply judgement or act, in the context of delivering, commissioning, or assuring taxpayer funded health and care services is, or could be, impaired or influenced by another interest they hold."
