# 4. The name of the person at BSMHFT who made the decision to refuse the funding, the reason for this, and the date this was communicated back to NHSE

The decision to decline the funding was established within two meetings.

The first meeting reviewed the bid offer and the leads of the Trust's Personality Disorder Service noted potential issues with the funding offer.

The second meeting consisted of further discussions and it was concluded by the Trust's Personality Disorder Service leads as well as the lead from NHSE, that the offer would not be pursued for the 2021/2021 financial year.

The rationale for declining the funding was based on factors which existed at the time;

- KUF was only funded for delivery in secure care and the offer was specifically to deliver KUF.
- The Trust did not have the resource to provide the necessary support for the role.
- The offer made to the Trust is for a 12-month post, with a commitment from the Trust to make the post substantive after that period, this commitment could not be given.

Finally, as part of the offer NHSE were clear that this is an optional funding offer. Therefore, systems are only invited to request access to this funding if they are content to take up the offer, and if they are confident that the conditions for receiving funding can be met within the timelines of the offer.

Several staff from clinical services in both the Trust, FTB and Patient Experience Team were involved in this decision making.
