The Trust has a health and safety dashboard which includes Environmental Risk Assessment completion levels, Ligature Risk Assessments, Fire Risk Assessments, CAS Alert status, RIDDOR reporting, Return to Work Risk Assessments and Pregnancy Risk Assessments, DSE Assessments plus usage of lone working devices. In addition, we report on training levels relating to Health and Safety and Fire Safety through our mandatory training reports. Incidents aligned to Health and Safety and Fire Safety are reviewed through our Eclipse Incident Management System and are reported on a quarterly basis to our Health and Safety Committee.
