I am seeking information concerning the impact of COVID-19 on Child and Adolescent Mental Health Services, specifically inpatient care facilities (Tier 4 CAMHS).

3. Were any of these patient discharges a direct result of covid-19?

Response

Birmingham and Solihull Mental Health NHS Foundation Trust provide a low secure inpatient Child and Adolescent Mental Health Service (CAMHS) and a medium secure inpatient Forensic Child and Adolescent Mental Health Service (FCAMHS).

The low secure inpatient Child and Adolescent Mental Health Service (CAMHS) provides multi-disciplinary assessments, mental health intervention and treatment for patients with mental health difficulties, until their 18th birthday.

The medium secure inpatient Forensic Child and Adolescent Mental Health Service (FCAMHS) provides multi-disciplinary assessments, mental health intervention and treatment for patients with forensic history and complex mental health difficulties, until their 19th birthday.

Both services are nationally commissioned and available to patients across England.

Please note that the data provided only relates to patients within the inpatient CAMHS and FCAMHS.

2. How many patients were discharged from inpatient care in each month from February 2019 to May 2020?

There have been no patients discharged as a direct result of Covid-19.

4. Did you restrict parent or family visits during lockdown?

The Trust had initially restricted visits, however with the assistance of the Infection Prevention and Control Team a plan was implemented to support family visits to the Trust's CAMHS services.

5. Did you test and isolate new admissions to inpatient wards?

The Trust tested all new admissions and requested a period of isolation however as the results from the Covid-19 tests were received within 24 hours, isolation was not required outside of this period.

6. How many of your inpatients were diagnosed with coronavirus?

There have been no inpatients within the CAHMS service diagnosed with Covid-19.

7. How many of your patients have had their discharge dates delayed due to covid-19?
