The service currently accepts children and young people, until their 19th birthday, who are residents in the borough of Solihull, go to school or college in the Solihull area, or have a Solihull GP.

Of the above figures, there was a total of 7 Children and Young people in time period A and 6 Children and Young People in time period B that had no contact at all with Solar or where attempts weren't made to contact them. The reasons for the 12 weeks without contact were primarily relating to awaiting medical appointments (time period A) and the temporary stepdown of groups owing to COVID (time period B). In regard to the remaining 57 instances of reported no-contact, either contact was made but appointments were not recorded correctly on our electronic patient record system, contact had been made by a team within Solar but not by the team the referral was open to, or appointments had been offered but not accepted (through either cancellation or DNA).
