The Trust predominately covers Birmingham and Solihull area however, our inpatient Child and Adolescent Mental Health Service (CAMHS) and Forensic Child and Adolescent Mental Health Service (FCAMHS) covers all local authorities across England as these services are nationally commissioned.

## 2. Do you provide services for people who have?

- 1. An intellectual disability mild.
- 2. An intellectual disability moderate.

The Trust is not commissioned to provided services for Intellectual Disability, Physical Disability, Sensory Impairment or Autism however, if patients have a secondary diagnosis of Intellectual Disability or Autism the Trust will provide support were appropriate.

Furthermore, the Trust, Barnardo's and Autism West Midlands work together to provide emotional wellbeing, mental health services and support with the listed disabilities through the provision of the Trust's Child and Adolescent Mental Health Service (CAMHS), Solar.

Please note that the child or young person must exhibit emotional and mental health needs to receive assistance from the Trust's CAMHS service.

Solar currently accepts children and young people, until their 19th birthday, who are residents in the borough of Solihull or have a Solihull GP. For information on children and young people in receipt of CAMHS services in Birmingham, please redirect your request to Forward Thinking Birmingham Service which is hosted by Birmingham Women's and Children's Trust.

## 3. Do you provide services for?

- 1. Children and young people.
- 2. Adults

The Trust delivers several adult mental health services throughout Birmingham and Solihull. Our services support people in the community through outpatient facilities, acute care, day services and community teams. We also have several inpatient units for adults offering acute care, rehabilitation and recovery, medium secure services to men and women and low secure services to men

Furthermore, the Trust offers a number of services for children and young people with mental health conditions. These include early intervention and detection, community services and inpatient services.

Please note the following for the Trust's CAMHS Service,

• The Trust's CAMHS service (Solar) explicitly covers patients until their 19<sup>th</sup> birthday and they must be either residing within the Solihull area or have an established GP

in Solihull. For information on children and young people in receipt of CAMHS services in Birmingham, please redirect your request to Forward Thinking Birmingham Service which is hosted by Birmingham Women's and Children's Trust.

- The Trust's inpatient Child and Adolescent Mental Health Service (CAMHS) provides mental health intervention and treatment for patients with mental health difficulties, until their 18th birthday
- The Trust's inpatient Forensic Child and Adolescent Mental Health Service (FCAMHS) provides multi-disciplinary assessments, mental health intervention and treatment for patients with forensic history and complex mental health difficulties, until their 19th birthday.
- Inpatient CAMHS and FCAMHS is nationally commissioned and available to patients across England.

The work is carried out by Individuals and groups.

The interventions undertaken are reactive to the needs of patients care, support and treatment.

Currently the Trust does not have a policy or guidance in relation to staff working with patients suffering with Intellectual Disability around sexual or romantic relationships, gender or sexual orientation issues and general sexual health.

However, the Trust does have an Equality, Diversity and Inclusion policy which provides a framework for patients, staff, and visitors to be treated with dignity, respect, and compassion.
