

## Community Integrator Proactive Prevention Pilots Programme

### Background

The Integrated Neighbourhood Teams (INTs) were established in Birmingham and Solihull as part of a wider effort to improve health outcomes and emotional wellbeing of local citizens, reduce health inequalities, and provide a consistent approach across the region. INTs take a holistic approach to strengthening neighbourhoods, complementing and supporting existing plans to promote healthy and independent living, striving to reduce the number of unnecessary GP visits, hospital admissions and premature admissions to social care. INTs take practical steps to identify and support individuals that would benefit from preventative support.

### Who we are

The objective of the Programme is to support the Integrated Neighbourhood Teams (INTs) to take practical steps forward in identifying and supporting individuals that could most benefit from preventative support.

Partner health and social care organisations will share certain data they hold about you so that diagnostic work can be carried out to support the Programme. These Partners are:

The health and social care Partners involved will keep your information secure and confidential and each is registered with the Information Commissioner's Office (ICO) as a Data Controller.

The health and social care Partners will share information securely with Birmingham Community Healthcare NHS Foundation Trust (BCHC) as the 'host' organisation. Newton Europe Limited (Newton), a UK-based company, has been appointed as a Data Processor to perform the diagnostic work on behalf of the Data Controllers'. Newton will develop a framework to enable teams to

effectively evaluate the impact of the pilot schemes and will continue to design and shape the approach in response to these findings. These findings will be presented to the Partners and help them to achieve a level of understanding that will allow an informed decision to take place about how to move forward. Newton has expertise in delivering population health and neighbourhood team programmes in London, Northamptonshire, Essex and Norfolk. This Privacy Notice explains how your personal information will be used, what for, who will be able to see it and why.

### **What will your personal information be used for?**

The Programme will support both shorter / longer-term outcomes and the wellbeing of patients.

1. The scope of the work will include:
  - Analysis of data to identify trends, patterns and variations, creating a view of which individuals could benefit from preventative support.
  - Collaborative case review workshops, to form a view of the potential for prevention and available interventions.
  - Deep dive studies into specific prioritised interventions, to understand effectiveness, best practice, and any blockers.
2. Supporting pilot teams to design and establish an approach to any identified opportunities, including defining key outcomes for monitoring.

### **What information will be shared?**

The information that will be shared by the Partners is shown below.

- Personal data: NHS Number, Sex, Ethnicity, Date of birth, Date of death (if applicable), Post Code, Current Living Circumstance (nursing home, residential home, supported living)
- Data concerning health: appointments, referrals, procedures, symptoms, attendances, diagnoses, investigations, treatments, activity, alerts, care package, discharge, number of repeat prescriptions

### **Our lawful basis for processing your information**

Each Partners organisation and Newton must follow the law to make sure they always handle your personal information in a lawful way.

The legal basis for the processing of your personal data shall be:

For the Data Controllers:

- Art 6(1)e UK GDPR ('performance of a task carried out in the public interests or in the exercise of official authority')
- Art 9(2)h UK GDPR ('provision of health and social care') in conjunction with Section 10 (1)(c) and Schedule 1 Part 1 paragraph 2(2)(f) of the DPA 2018 and Art 9(2)(i) UK GDPR ('public health'), in conjunction with Schedule 1 Part 1, paragraph 3 of the DPA 2018

For the Data Processor, Newton:

- Art 6(1)b UK GDPR ('performance of a contract')

## **Who do we share your information with**

Personal Data will be sent securely by each Data Controller to BCHC via a secure email method.

BCHC will transfer personal data into its secure data warehouse and will make it available for approved Newton staff to carry out their diagnoses work. Any patient that has opted out of their data being used for analysis under the National Data Opt-out will have their wishes applied. Data is fully encrypted during transit and remains under the control of BCHC once it has been shared.

## **How long will we keep your information?**

Each partner organisation keeps a record of your health / social care information in line with 'The NHS Records Management Code of Practice 2021'. Your personal information used as part of this Programme will only be kept by BCHC for the duration of the Programme.

## **Your rights**

The UK GDPR provides certain rights for individuals whose personal data is being used, processed or transferred.
