Please could you provide information on the following:

1. **Do you accept referrals for currently serving Military Personnel for an ADHD Assessment.**

Referral's will be accepted as long as the individual is registered with a Birmingham and Solihull commissioned GP.

**If the answer to (1) is "no", to what agency or service do you direct the serving military person to.**

2. **If the answer to (1) is "yes", how many referrals have you received, by year, for the last 5 years.**

We are unable to report on referrals received that are Military Personnel. This is because the data we hold currently does not accurately reflect the requested information and may not be known until the ADHD assessment has taken place.

Obtaining the requested information will require a manual check of each Rio record to determine patients serving military personnel, thus exceeding the threshold of carrying out this task.

3. **How many assessments for ADHD have you completed, by year, for the last 5 years, for currently serving Military Personnel**

The ADHD service is commissioned to provide pharmacological treatment for those who have a confirmed diagnosis of ADHD.

We will undertake reasonable adjustments work when initially diagnosed however, we are otherwise not commissioned to provide non-pharmacological treatment for ADHD.

**8. What is your current waiting time for all adult referrals for an ADHD Assessment.**

For referrals currently being received the expected wait is 298.76 weeks based on assessment capacity in the last financial year (2022-2023).

**9. How many Shared Care Agreements do you currently have for serving military personnel with an ADHD diagnosis.**

The Trust is unable to provide a response to your query, this is because we do not readily capture the data.

Obtaining the requested information will require a manual check of each Rio record to determine patients serving military personnel, who have a shared care agreement. Thus will exceed the threshold of carrying out this task.
