a. What is your process for reviewing and deciding whether to accept or reject adults who have been referred for an ADHD assessment.

Each referral when received is triaged by a senior Clinician within the team to review appropriateness for assessment.

If there is limited information (e.g. no reference to current symptoms or clinical rationale for assessment, lack of proof of an existing diagnosis, no evidence of symptoms prior to the age of 12, etc), then it is sent back to the referrer to request further information.

If there is significant drug or alcohol use that would impact upon an accurate assessment, the Trust will signpost the individual to CGL (for Birmingham) or SIAS (for Solihull), so that they can provide intervention before we can carry out an assessment. All referrals are assessed on an individual basis.

iii.Is your organisation confident that it is satisfying the NICE guidelines for adults with ADHD?

The ADHD service within BSMHFT is commissioned for the assessment, diagnosis, and pharmacological treatment of ADHD.

We do not offer psychological intervention for the treatment of ADHD (excluding reasonable adjustments, which we do undertake).

We are mostly compliant with NICE guidance within the service we offer and, as we are not commissioned to offer psychological intervention, we signpost those who do require this to the suitable agency. Therefore, we are confident that we satisfy the NICE guidelines for adults with ADHD.
