- The data for table 2 is explicitly in relation to patient-on-patient incidents, which has been captured within our Incident reporting system Eclipse and does not record rapes separately.
- For the data provided in table 2, note that the Trust's Eclipse system does not readily hold details of whether these incidents were reported to the police and if there was a criminal charge.

Obtaining this information will require an exhaustive and manual search into each incident and this exceeds the threshold to carry out this task. The Trust therefore rely on exemption Section 12 of the Freedom of Information Act 2000 to deny this aspect of your request.
