N.B. By registered clinicians, I mean those statutory regulated such as by the NMC as a Nurse Associate would be, and accredited clinician those such as a Physician's Associate with the currently voluntary scheme by RCPL or UKCP/BACP etc, for an accredited psychotherapist or counsellor. For registered clinicians it would need be broken down to their sub or sub-sub speciality. Like for medical psychiatry practioners (i.e. registrar or consultant general adult psychiatrist or consultant psychiatrist in medical psychotherapy and then any dual CCT psychiatrist such as consultant psychiatrist in intellectual disability or child and adolescent and a consultant general adult psychiatrist as well), registered mental health nurses, registered learning disability nurses, any dual trained registered nurses (e.g. adult nursing and mental health nursing), registered allied health professionals (e.g. occupational therapist, speech and language therapist, counsellor), creative therapist (e.g. art/music/drama/dance movement therapist), your own NHS FT employed psychiatric social worker, your own NHS FT employed psychiatric pharmacist, your own NHS FT employed approved mental health professional, your own NHS FT employed best interest assessor and your own NHS FT employed forensic, social supervisor etc.

7. As according to point 3.4.2 of your Access to Information procedure, available online, may I pleased be furnished with the more detailed internal document or procedure of the FoI complaints, as any internal review I may sadly need to ask for "falls outside the usual NHS complaints procedure". I would presume this is referring to the current patient, NHS and Local Authority Social Services and National Health Service Complaints (England) Regulations 2009. I do not understand why this NHS FT would not deem a FoI complaint under this regulation, when neighbouring Trusts do. I do appreciate from past experience, you will not sadly speculate on how other statutory authorities will deal with such situations themselves.

Please note that FOI complaints are managed via an internal review process which is managed within the Information Governance Team and is overseen for sign-off by the Trust's Executive Director of Finance and Senior Information Risk Officer (SIRO) as noted in the attached data flow chart.

FOI requests are managed in line with the Freedom of Information Act 2000.

8. Who the current Fol lead is for this NHS FT and the internal review methodology (i. e. is an employment originated, upheld, partially upheld or not upheld result based outcomes used) sadly if my above point seven information is not clarified to me in detail and released to me in a timely fashion. Clarification: I am asking for the formal complaints procedure for Fol Act request and how this complaint is dealt with by the Trust. I sadly do not understand the difference of a complaint regarding Fol and said internal review by the Trust as well.

Please see attached data flow chart and note that FOI requests are currently processed by the Information Governance & Freedom of Information (FOI) Administrator who is part of the Information Governance Team. Management and oversight responsibility is with the Head of Information Governance and Associate Director of Performance and Information.
