It would be greatly appreciated if you could please provide me, under the Freedom of Information Act, details in respect to the Clinical Waste Contract/s that your trust currently has in place.

The details we require are as follows:

- 1. Suppliers who applied for inclusion on each framework/contract and were successful and not successful at the PQQ & ITT stages**

We did not use a framework, rather we went to open tender and the Clinical Waste Contract was awarded to Tradebe.

Please note that the Trust is unable to disclose and identify the unsuccessful suppliers.

This is because disclosure of the requested information may seriously prejudice the interests of the incumbent supplier and any third parties that may wish to bid to supply this service in the future.

- 2. Actual spend on this contract/framework (and any sub lots), from the start of the contract to the current date**

The cost in 22/23 FY was £70,565 for Clinical waste for the entire estate.
The cost in 23/24 FY was £67,340 for Clinical waste for the entire estate
