The Trust's position as per our Ligature Risk Reduction Policy, is that bin liners are not permitted within in en-suites, bedrooms and toilets or where patients have unsupervised access.

No other types of plastic bags are permitted.

Should any patient areas have a different approach for these rooms then they would need to consider local risk assessment with amended environmental and ligature risk assessments (ERA/LRA) supported by the health and safety team.

It should be noted that bin liners and other types of bags will only be used in controlled rooms on in-patient areas. Controlled rooms are those that are usually locked or only allow supervised access. Examples of these include - treatment rooms, examination rooms, domestic wet and dry rooms, consultation rooms, kitchens, ward offices and laundries.
