I am writing to request information under the Freedom of Information Act 2000. I would be grateful if you could provide the following data relating to your Trust's Mother and Baby Unit (MBU) called the Chamomile suite:

1. Serious incidents:

- The number of serious incidents reported in the Mother and Baby Unit each year for the past five years (or for as many years as data is available, if it is fewer than five years).
- o A brief description of each serious incident, if possible.

No commissioner reportable serious incidents were reported on the Trust's incident reporting system between Jan 2020 – Dec 2024. (note: from October 2023, NHS England replaced the Serious Incident framework with the Patient Safety Incident Response Framework)

2. Incidents involving violence:

The number of incidents involving violence (including patient-on-patient, patient-on-staff, or other) in the MBU for each of the past five years.
