I am writing to request the following information under the Freedom of Information Act 2000. Please provide data for the period April 2024 to March 2025, broken down by calendar month where applicable as well as planned capital works for the current year 2025/2026.

The following request:

1. People in Beds

a. Acute Mental Health Placements (Out-of-Trust / Private Sector)

- The number of **female** patients placed in **private sector or out-of-trust acute mental health beds** each month.
- The number of **male** patients placed in **private sector or out-of-trust acute mental health beds** each month.

b. PICU (Psychiatric Intensive Care Unit) Placements (Out-of-Trust / Private Sector)

- The number of **female** patients placed in **private sector or out-of-trust PICU beds** each month.
- The number of **male** patients placed in **private sector or out-of-trust PICU beds** each month.

c. Rehabilitation Mental Health Placements

- The number of patients placed in **rehabilitation mental health placements**, broken down by **gender (male/female)** and by **month**.
