This will most likely be recorded on the email servers, and hopefully shouldn't be too difficult for staff members to retrieve or recollect
- Details of any staff training undertaken Clarification: any staff, any contractors, any training which was implemented as a result of having received a PFD, and any memos sent between any staff members as a result of receiving any PFD.
- Memos sent- Clarification: I would be expecting to receive correspondence
 only between members of staff / practitioners who worked with the
 individual at the centre of each PFD. Essentially, I am looking for evidence of
 any communication between staff that took place in regards to having
 received a Prevention of Future Death Report. This will most likely be
 recorded on the email servers, and hopefully shouldn't be too difficult for
 staff members to retrieve or recollect

The Trust is unable to provide the requested emails, memos or staff training data.

This is because we do not have the information readily captured within a case management system.

Obtaining the requested information will require exhaustive and manual searches through large cohort of data.

This therefore exceeds the threshold to carry out this task, and we rely on exemption Section 12 of the Freedom of Information Act 2000, to deny this aspect of your request.

However, we can provide the attached minutes.

Please note that an exemption Section 40 of the Freedom of Information Act 2000 has been applied.

This therefore means personal information relating to staff, patients, and third parties have been redacted.
