For your adult eating disorder service from January 2025-November 2025 what were the BMI of inpatients and community patients with an eating disorder at the time they were discharged?

Date range of data set: 01/01/2025 - 26/11/2025.

We are not commissioned for CYP Inpatient Eating Disorder services.

BMI / Weight for Height measurements could be up to 30 days before discharge.

BMI / Weight for Height measurements have not been recorded in a reportable format in all cases.

As of 1st July 2025, Forward Thinking Birmingham – service previously hosted by Birmingham Women's and Children's Trust, has been transferred to BSMHFT.
